STAFF REQUEST FOR AN EXTENSION OF TIME

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and pursuant to the February 6, 2025, *Order Directing Notice and Establishing Time for Responses*, states as follows:

1. On January 17, 2025, Evergy Metro, Inc., d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc., d/b/a Evergy Missouri West (“Evergy” or “Applicant”) filed its *Application for Variances* (Application).

2. Evergy requested that the Commission grant waivers from:

a. The Commission’s rules 20 CSR 4240-13.050(9), 13.055(3)(C) and (D) that requires Evergy to provide a door knock or door hanger at the time of the service disconnection., and

b. Evergy is asking for a variance from 20 CSR 4240-13.050(8) and 20 CSR 4240-13.055(3)(A) and (3)(B) to waive the requirement that the notification must be a phone call.

3. On February 6, 2025, the Commission ordered Staff to file its *Recommendation* no later than March 6, 2025.

4. On February 18, 2025, Staff sent data requests to the Applicant. Responses are due to Staff by March 6, 2025.¹ Since that request Staff has sent Evergy additional data requests.

5. Staff requests that the Commission extend the deadline for its recommendation to May 5, 2025. Staff will proceed as quickly as possible to offer the Commission its recommendation.

WHEREFORE, Staff respectfully requests that the Commission accepts its *request for an extension of time* and grant such other and further relief as the Commission considers just in the circumstances.
