## ORDER GRANTING MOTION TO ESTABLISH A CASE

Issue Date: March 6, 2025

Effective Date: March 6, 2025

On March 3, 2025, the Staff of the Commission (Staff) filed Staff's Motion to Establish a Case. Staff states that Summit Natural Gas of Missouri Company (Summit) is subject to Commission jurisdiction under Section 386.020, RSMo. Further, Staff states that on February 24, 2025, a reportable natural gas incident occurred at Spark by Hilton Branson Meadows hotel located at 263 Shepherd of the Hills Expressway in Branson, Missouri. According to Staff, multiple people were injured in this incident.

Staff states that it has begun a formal investigation into the incident, and requests that the Commission open a case to allow it to receive further information. Staff indicates that it anticipates it will file an investigatory report or a status report by May 30, 2025.

The Commission finds that it should establish a case to receive information relevant to the above-described incidents, and to determine what, if any, action the Commission should take. Thus, the Commission will establish Case No. GS-2025-0237.

### THE COMMISSION ORDERS THAT:

1. Case No. GS-2025-0237 is hereby established to receive an incident report from Staff pertaining to the natural gas incident that occurred on February 24, 2025, at Spark by Hilton Branson Meadows hotel located at 263 Shepherd of the Hills Expressway in Branson, Missouri.

2. Staff shall file either its final incident report or a status report no later than May 30, 2025.

3. This order shall become when issued.
