On August 20, 2019, Union Electric Company d/b/a Ameren Missouri filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file revised tariffs implementing its Voluntary Green Program / Pure Power Program pilot. The Commission's rule provides that if the tariffs are not filed within 180 days, the noticed case shall close.

More than 180 days have passed since Ameren Missouri filed its notice and by terms of the regulation, File No. ET-2020-0042 has closed.


