## ORDER SETTING INTERVENTION AND RESPONSE DEADLINES AND DIRECTING STAFF RECOMMENDATION

On March 11, 2025, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed an application for a depreciation authority order to transfer an existing plant utility account to a new plant utility account due to the implementation of a Federal Energy Regulatory Commission (FERC) order. Evergy Missouri West also requests waiver of the Commission's 60-day notice requirement under Commission Rule 20 CSR 4240-4.017.

The Commission will set a deadline for intervention requests and responses to the application. The Commission will also direct its Staff to file a recommendation on the application.

### THE COMMISSION ORDERS THAT:

1. Any person or entity wishing to intervene in this matter shall file an application to intervene no later than March 27, 2025.
2. Any parties wishing to respond to the application shall do so no later than April 11, 2025.
3. Staff shall file a recommendation on the application, or a request for additional time, no later than April 11, 2025.
4. This order shall be effective when issued.
