**ORDER DIRECTING COMPLAINANT TO SHOW CAUSE WHY THE
COMPLAINT SHOULD NOT BE DISMISSED**

Issue Date: March 13, 2025

Effective Date: March 13, 2025

On March 5, 2025, the Commission issued an order setting a procedural schedule in this complaint. The order set a prehearing conference for March 11, 2025, beginning at 2:00 p.m. Instructions on how to appear at the conference were included in the order. Counsel for Spire and the Commission's Staff were present at the prehearing conference via videoconference. Mariah Gordon failed to appear by videoconference or telephone, and did not contact the Commission prior to the prehearing conference to request a continuance.

Commission Rule 20 CSR 4240-2.090(5) provides that "[f]ailure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of ...the party's complaint...unless good cause for the failure to appear is shown". The Commission will not dismiss the complaint without giving Mariah Gordon an opportunity to explain why she did not attend the prehearing conference. Therefore, Mariah Gordon shall file a pleading showing cause why her complaint should not be dismissed for failure appear at the prehearing conference.

THE COMMISSION ORDERS THAT:

1. Mariah Gordon shall file a pleading no later than March 21, 2025, explaining why she did not appear at the prehearing conference and why her complaint against Spire should not be dismissed.
2. This order is effective when issued.
