ORDER DIRECTING STAFF RECOMMENDATION ON COMPLIANCE FILING

Issue Date: March 14, 2025 On December 4, 2024, the Commission issued its *Order Approving Stipulation and Agreement*. Paragraph 12 of the agreement provided that Spire Missouri Inc. d/b/a Spire would demonstrate compliance with Paragraphs 6 through 11 of the agreement within 90 days of the Commission's order.

On March 3, 2025, Spire filed its *Compliance Filing*. The Commission will direct its Staff to file a recommendation as to whether Spire has complied with Paragraphs 6 through 11 of the agreement.

THE COMMISSION ORDERS THAT:

1. No later than April 9, 2025, Staff shall file a recommendation, or a status report stating when it expects to file a recommendation, regarding Spire's *Compliance Filing* and whether Spire has complied with Paragraphs 6 through 11. In addition, Staff shall make a recommendation on whether the file may be closed.

2. This order shall be effective when issued.
