- 1. The Commission issued its Order Granting Certificate of Convenience and Necessity (Order), on February 24, 2021, with an Effective Date of March 26, 2021.
- 2. The closing contemplated by the Order was completed on April 30, 2021.
- 3. MAWC filed a Notice of Closing on July 16, 2021.
- 4. MAWC filed a Notice of Completion on September 14, 2022 providing notice that pursuant to the Order, the following have been completed.
 - (1) MAWC provided training to its call center personnel regarding rates and rules applicable to the Table Rock water system customers.
 - (2) MAWC included the Table Rock water system customers in its established monthly reporting to the Customer Experience Department Staff on customer service and billing issues and will continue on an ongoing basis.
 - (3) MAWC distributed to the Table Rock water system customers an informational brochure detailing the rights and responsibilities of the utility and its customers regarding its water service, consistent with the requirements of Commission Rule 20 CSR 4240-13, within thirty (30) days of closing on the assets.
 - (4) MAWC provided to the CXD Staff an example of its actual communication with the Table Rock water system customers regarding its acquisition and operations of the water system assets, and how customers may reach MAWC.
 - (5) MAWC provided to the CXD Staff a sample of ten (10) billing statements from the first month's billing.

- 5. MAWC hereby provides notice of the following.
 - (1) MAWC has installed a new main and is currently coordinating with residents to install new service lines, meter pits and setters. MAWC anticipates new meters installed and billing to commence in Fall 2025.

WHERFORE, MAWC respectfully requests that the Commission consider this Notice of

Closing and such further orders as it shall find to be reasonable and just.
