## **NOTICE OF COMPLETION**

states the following to the Missouri Public Service Commission (Commission):

1. The Commission issued its Order Granting Certificate of Convenience and Necessity ("Order") on October 12, 2022 with an Effective Date of November 11, 2022.

2. The closing contemplated by the Order was completed on December 19, 2022.

3. MAWC filed a Notice of Closing on December 20, 2022.

4. MAWC filed a Notice of Completion on February 13, 2023 providing notice that pursuant to the Order, the following have been completed.

(1) MAWC has provided training to its call center personnel regarding rates and rules applicable to the Pom-Osa water system customers.

(2) MAWC will include the Pom-Osa water system customers in its established monthly reporting to the CXD Staff on customer service and billing issues, on an ongoing basis, after closing on the assets.

(3) MAWC has distributed to the Pom-Osa water system customers and informational brochure detailing the rights and responsibilities of the utility and its customers regarding its water service, consistent with the requirements of Chapter 13 of the Commission Rules (20 CSR 4240-13).

(4) MAWC has provided the Customer Experience Department ("CXD") Staff an example of its actual communication with the Pom-Osa water system customers regarding its acquisition and operations of the water and sewer system assets, and how customers may reach MAWC.

(5) MAWC has provided the CXD Staff a sample of ten billing statements from the first month's billing.

- 5. MAWC hereby provides notice that pursuant to the Order, the following have been completed.
  - (1) MAWC installed meters for each customer within the Pom-Osa service area by January 2024.
  - (2) The first full billing period for each customer within the Pom-Osa service area was July 2024.

WHERFORE, MAWC respectfully requests that the Commission consider this Notice of

Completion and such further orders as it shall find to be reasonable and just.
