- On January 10, 2025, the OPC filed the Cross-Rebuttal testimony of Ms.
   Lena M. Mantle in the above styled case.
- 2. This testimony responded, in part, to the Direct/Rebuttal Testimony of Mr. Jarrod J. Robertson, a witness for the Saff of the Missouri Public Service Commission ("Staff").
- 3. On the same day, Staff filed Mr. Robertson's Cross-Rebuttal/Surrebuttal
  Testimony.

cross-rebuttal testimony in regards to the issue upon which Ms. Mantle originally

filed cross-rebuttal testimony.

7. As stated, the OPC has not been afforded any opportunity to address the

changes made in Mr. Roberson's cross-rebuttal testimony and will not be afforded any

opportunity to do so in pre-filed testimony under the currently ordered procedural

schedule.

WHEREFORE, the Office of the Public Counsel respectfully requests the

Commission issue an order granting leave to file the attached Supplemental

Testimony of Lena M. Mantle and to grant such other relief as is just and reasonable

under the circumstances.
