COME NOW Frank A. Caro, Andrew O. Schulte, and Sean Pluta of the law firm Polsinelli PC, and hereby enter their appearance as attorneys for Google LLC (“Google”). Commission Rule 20 CSR 4240-22.020(56) defines “Stakeholder Group” as including any entity granted intervention in a prior Chapter 22 proceeding of the electric utility. That regulation also provides that such entities are to be parties to any subsequent related Chapter 22 proceeding of the electric utility without the necessity of applying to intervene in the subsequent case.¹

Google was a party to the 2024 Triennial Integrated Resource Planning (“IRP”) Compliance Filing of Evergy Metro, Inc. and Evergy Missouri West, Inc. (collectively, “Evergy”) in Case Nos. EO-2024-0153 and EO-2024-0154, respectively. Accordingly, Google should be recognized as a party to the above-captioned cases without an application to intervene.
