# ORDER SHORTENING TIME TO RESPOND TO MOTION REQUESTING LOCAL PUBLIC HEARINGS

On March 31, 2025,<sup>1</sup> the Staff of the Commission (Staff) filed a *Motion Requesting Local Public Hearings and for Expedited Treatment* (Motion). The Motion requests scheduling an in-person local public hearing in eastern Grundy County or western Sullivan County, preferably on April 22, and a virtual local public hearing, preferably on April 23. The Motion also requests an order regarding local public hearings be issued by April 4 in order to provide at least ten business days' notice to customers. Commission Rule 20 CSR 4240-2.080(13) provides that parties have ten days to respond to any pleading, unless otherwise ordered by the Commission. The ten days for parties to respond to the Motion extends beyond the date requested for an order. Accordingly, the time for responses to the Motion will be shortened.

1. Any responses to the Motion must be filed no later than 10:00 a.m. on April 3, 2025.

2. This order shall be effective when issued.
