## ORDER CANCELING CERTIFICATE

Issue Date: March 10, 2025

Effective Date: April 9, 2025

On February 24, 2025, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the certificate of service authority of Pareteum Corporation (Pareteum or the Company) to provide Interconnected Voice over Internet Protocol (IVoIP) services in Missouri. The Commission previously granted a certificate to the Company to provide IVoIP services in File No. DA-2022-0251.

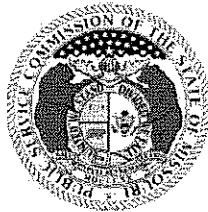
Staff's motion states that Pareteum failed to submit an annual report due to the Commission for calendar years 2022 and 2023. In addition, the Company failed to file its Statement of Revenue report and pay the annual assessment for fiscal years 2024 and 2025. Staff recommended that the Commission cancel the Company's certificate of service authority. The Company has not responded to Staff's contacts to resolve these deficiencies.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. No responses were received.

Based on Staff's motion, the fact that Pareteum failed to submit annual reports in 2022 and 2023, failed to file its Statement of Revenue and pay its annual assessment for fiscal years 2024 and 2024, because the Company cannot be reached by Staff, and has not requested a hearing or otherwise responded, the Commission finds that the certificate of service authority granted to Pareteum shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of service authority to provide IVolP services in Missouri, granted to Pareteum Corporation in File Number DA-2022-0251, is canceled.
2. This order shall become effective on April 9, 2025.
3. This case shall be closed on April 10, 2025.




