**EVERGY MISSOURI METRO’S AND EVERGY MISSOURI WEST’S
MOTION FOR A VARIANCE TO EXTEND TIME TO FILE RESOURCE PLANS**

COMES NOW, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Missouri Metro”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”)(collectively “Evergy” or the “Companies”), pursuant to 20 CSR 4240- 22.080(13) and hereby requests the Commission grant an extension until April 30, 2021 to file their respective triennial compliance filings under 20 CSR 4240-22.080. In support of their motion, the Companies state as follows:

1. Pursuant to 20 CSR 4240- 22.080(1) the Companies’ respective resource plans are due to be filed on April 1, 2021.
2. The Companies hereby request an extension until April 30, 2021 for their respective filings. 20 CSR 4240- 22.080(13) permits the Companies to request a variance in the resource plan filing due date for good cause shown. Given the recent extreme cold weather events, Evergy is running additional scenarios to include in its resource plan modeling. The Companies wish to discuss these scenarios with stakeholders before filing its resource plans. The recent extreme weather event is also the reason why this variance request was not filed twelve months before April 1, 2021 as specified in the above cited rule.

3. Counsel for all of the parties to these dockets, with the exception of IBEW 412, have indicated that they do not oppose this request. IBEW 412 has not responded to the Companies inquiries regarding this extension.

WHEREFORE, Evergy Missouri Metro and Evergy Missouri West respectfully request that the Commission allow additional time to file their respective Resource Plans.
