On September 23, 2024, the Manager of the Manufactured Homes and Modular Units Program of the Missouri Public Service Commission (MHMU Manager) filed a complaint with the Commission against Stephen L. Johnson d/b/a Colony Cove, Inc. and/or Sequiota Investments, Inc (Respondent). On November 21, 2024, Respondent filed its Answer. On December 20, 2024, a procedural conference was held.

The complaint is now ready to move to resolution. To that end, the Commission will direct the parties to file, jointly if possible, a proposed procedural schedule. Unless requested, the Commission will not schedule another procedural conference.

The Commission will order the submission of a joint proposed procedural schedule that includes the following:

- Submission of List of Issues and Order of Witness, Order of Opening Statements, and submission of Position Statements - all due at least ten days in advance of the hearing;
- At least one settlement conference;
- Cut-off dates for service of discovery requests and responses;
- Briefing schedule allowing for ten business days for transcript preparation.

Requests for expedited hearing transcripts must be made before the procedural schedule is established.

THE COMMISSION ORDERS THAT:

1. No later than April 23, 2025, the parties shall jointly submit, if possible, a proposed procedural schedule as described in this order, or a status report. The Staff of the Commission shall coordinate and file the joint proposed procedural schedule.

2. This order shall be effective when issued.
