ORDER GIVING NOTICE, SETTING AN INTERVENTION DEADLINE, AND DIRECTING A RESPONSE

On March 28, 2025, the Staff of the Commission (Staff) filed a motion to revoke the Eligible Telecommunications Carrier (ETC) status of Q-Link Wireless, LLC, (Q-Link). Staff explains that due to actions taken against Q-Link and its CEO, the Federal Communications Commission (FCC) has suspended Q-Link from participating in any universal support programs and is seeking to disqualify Q-Link from future participation in all federal universal support mechanisms. Additionally, Staff asserts that Q-Link did not file a required annual report by January 31, 2025.

The Commission granted Q-Link an ETC designation in File No. RA-2012-0205, on September 26, 2012.

Staff notes that it has been unable to contact Q-Link using the company contact information maintained with the Commission.

The Commission will give notice of Staff's motion and will set a time for applications to intervene.

THE COMMISSION ORDERS THAT:

1. The Data Center of the Commission shall send a copy of this order to each eligible telecommunications carrier in the State of Missouri.

2. The Data Center of the Commission shall send a copy of this order to Q-Link and Q-Link's Missouri Secretary of State registered agent, Incorp Services Inc.

3. Q-Link shall file a response to Staff's motion no later than May 2, 2025.
4. Any applications to intervene are due no later than May 2, 2025.
