STAFF'S STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and states as follows:

- 1. On March 10, 2025, Union Electric Company d/b/a Ameren Missouri filed an application seeking authority to convey to and lease back from Audrain County, Missouri, certain real property known as the Vandalia Project site, as well as authority to execute and perform the necessary agreements to the conveyance (the "Application").
- 2. On March 12, 2025, the Commission issued its *Order Directing Notice, Staff to File Recommendation, and Setting Deadline for Responses* (the "Order"), which set a March 26, 2025, deadline for applications to intervene and which set an April 10, 2025, deadline for Staff to file a Recommendation regarding the Application or a status report indicating when it expects to file its recommendation.
 - 3. No applications to intervene were filed on or by March 26, 2025.

- 4. In compliance with the Order, Staff indicates that it can submit its recommendation or a status report no later than May 10, 2025. Staff will endeavor to file its recommendation earlier if possible.
- 5. Staff informed Ameren of the filing of this Status Report and Ameren does not object to Staff's request to file its recommendation no later than May 10.

WHEREFORE, Staff respectfully submits this Status Report, and respectfully requests the Commission accept the same and order Staff to file its recommendation or a status report regarding the Application no later than May 10, 2025, and for such other and further relief as the Commission considers just and reasonable under the circumstances.
