ORDER SETTING EXPEDITED DEADLINES FOR RESPONSES

Effective Date: April 15, 2025

On March 21, 2025, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (EMM) filed eight tariff sheets with a proposed effective date of April 21, 2025. The tariff sheets were assigned Tracking No. JE-2025-0134.

On April 15, 2025, the Staff of the Commission (Staff) filed *Motion to Suspend Tariffs, Open New Docket and for Expedited Treatment* (Motion). The Motion stated that the tariff sheet filings reflect substantial edits to EMM's Net Metering Option for Residential Time of Use rates.

The Motion further stated that Staff determined that the proposed tariff revision may be of interest to other parties, and requested that the Commission suspend the tariff sheets and direct Staff to file a recommendation. Staff indicated its recommendation would likely not be completed prior to May 14, 2025.

Due to the approaching effective date of the tariff sheets, Staff requested expedited treatment in the Commission's suspension of the tariff sheets – specifically that the suspension occur no later than April 20, 2025.

The Commission will set an expedited time for responses to EMM's filing of tariff sheets and to Staff's Motion.

THE COMMISSION ORDERS THAT:

1. Responses to EMM's tariff filing shall be filed no later than **noon** of April 18, 2025.
2. Responses to Staff's Motion shall be filed no later than **noon** of April 18, 2025.
3. This order shall be effective when issued.
