ORDER SETTING TIME TO CORRECT DEFICIENCY

On April 16, 2025, Paul Kazakevicius filed an Application to Intervene.

Commission Rule 20 CSR 4240-2.075(2)(F), requires that an application to intervene include:

A statement as to whether the proposed intervenor or new member supports or opposes the relief sought, or a statement that the proposed intervenor or new member is unsure of the position it will take with an explanation of why a position cannot be asserted based upon the initial filing(s) and when such position could be asserted or that the intervenor or new member intends to only provide or receive information and will not take a position on the issues.

The application states that Mr. Kazakevicius "advocates for renewable energy and energy efficiency efforts" which "may be adversely affected by a final order arising from this case." Mr. Kazakevicius does not offer a position as to whether he supports or opposes ATXI's application. The application to intervene is deficient and the Commission will permit Mr. Kazakevicius to correct this deficiency by supplementing or refiling his application to intervene including a position of support or opposition. The Commission will extend the time for Mr. Kazakevicius to file his application to intervene.

The Commission also notes that it is aware that Mr. Kazakevicius also submitted a consumer comment to this case file. The Commission informs Mr. Kazakevivius that the information in his comment is not considered part of his application to intervene. Therefore, if Mr. Kazakevicius would like that information to be considered in his application to intervene, he must add that information to his application to intervene.

THE COMMISSION ORDERS THAT:

- 1. No later than April 23, 2025, Paul Kazakevicius shall file a supplement to or new application to intervene including his position of support or opposition.
 - 2. This order is effective when issued.
