# ORDER APPROVING COMPLIANCE FILING AND CLOSING FILE

On December 4, 2024, the Commission issued its *Order Approving Stipulation* and *Agreement*. Paragraph 12 of the agreement provided that Spire Missouri Inc. d/b/a Spire would demonstrate compliance with Paragraphs 6 through 11 of the agreement within 90 days of the Commission's order.

On March 3, 2025, Spire filed its *Compliance Filing*. On March 14, 2025, the Commission directed its Staff to file a recommendation as to whether Spire has complied with Paragraphs 6 through 11 of the agreement.

On April 9, 2025, Staff filed its *Staff Recommendation* that the Commission approve Spire's March 3<sup>rd</sup> filing and close the case, subject to certain provisions. No responses to the *Staff Recommendation* have been filed.

### THE COMMISSION ORDERS THAT:

- 1. Spire has complied with Paragraphs 6-11 of the *Full and Unanimous*Stipulation and Agreement approved by the Commission in its order issued

  December 4, 2024.
  - 2. This file shall be closed on April 22, 2025.
- 3. If Spire finds that locates are not being performed within the requirements of Section 319.030, RSMo, Spire shall reopen this file by filing necessary amendments or supplements to Appendix 1 of the *Full and Unanimous Stipulation and Agreement* approved by the Commission in its order issued December 4, 2024.
- 4. Staff shall file a motion to reopen this file if, during safety inspections, it finds lack of compliance with the provisions of the *Full and Unanimous Stipulation and Agreement* approved by the Commission in its order issued December 4, 2024.
  - 5. This order shall be effective when issued.
