On April 18, 2025, Kevin Paul Hiatt and Rochelle Lynn Hiatt filed an Application to

Intervene.

Commission Rule 20 CSR 4240-2.075(2)(F), requires that an application to intervene

include:

A statement as to whether the proposed intervenor or new member supports or opposes the relief sought, or a statement that the proposed intervenor or new member is unsure of the position it will take with an explanation of why a position cannot be asserted based upon the initial filing(s) and when such position could be asserted or that the intervenor or new member intends to only provide or receive information and will not take a position on the issues.

The application states that Mr. and Ms. Hiatt "do not have a clear understanding of if

300 feet of ATXI's proposed route means a distance closer to or father from the front door of our family residence." Mr. and Ms. Hiatt do not offer a position as to whether they support or oppose ATXI's application. The application to intervene is deficient and the Commission will permit Mr. and Ms. Hiatt to correct this deficiency by supplementing or refiling their application to intervene including a position of support or opposition. The Commission will extend the time for Mr. and Ms. Hiatt to file their application to intervene.

1. No later than April 29, 2025, Kevin Paul Hiatt and Rochelle Lynn Hiatt shall file a supplement to or new application to intervene including their position of support or opposition.
