## ORDER CANCELING REGISTRATION

Issue Date: April 22, 2025

Effective Date: May 22, 2025

On April 8, 2025, RCLEC, Inc. filed a letter seeking to cancel its registration to provide basic local and non-switched local telecommunications service in the State of Missouri. The Commission granted RCLEC, Inc. its registration in the State of Missouri in File No. TA-2015-0186.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup>

Based on RCLEC, Inc.'s request, the Commission finds that the registration granted to RCLEC, Inc. to provide basic local and non-switched local telecommunications service in the State of Missouri shall be canceled.

**IT IS ORDERED THAT:**

1. The registration to provide basic local and non-switched local telecommunications services, granted to RCLEC, Inc. in File Number TA-2015-0186, is canceled.
2. This order shall become effective on May 22, 2025.
3. This case may be closed on May 23, 2025.
