On March 19, 2025, the Commission issued its *Order Approving True-Up Adjustment Tariff and Request for Expedited Treatment*. That order, which became effective April 1, 2025, provided that The Empire District Electric Company d/b/a Liberty fill out and file a monthly report until such time as the Capitol Subaccount is replenished.

Liberty's first monthly report, which would be due no later than May 1, 2025, should include the monthly form amounts for January through the end of April, less reconciliation amounts for April, as specified in the March 19, 2025, order.

THE COMMISSION ORDERS THAT:

1. Liberty shall file the information discussed in the body of this order in its first monthly report no later than May 1, 2025.
2. This order is effective when issued.
