ORDER DIRECTING FILING

On December 13, 2024, the Staff of the Commission (Staff) filed its recommendation regarding the Actual Cost Adjustment (ACA) of Union Electric Company d/b/a Ameren Missouri. Staff proposes adjustments to the ending ACA balances. Staff listed several recommendations, and requested the Commission order Ameren Missouri to respond to those recommendations within 30 days.

The Commission directed Ameren Missouri to respond to Staff's Recommendation. Ameren Missouri responded on January 15, 2025, in which it disagreed with a Staff adjustment.

The Commission convened a procedural conference for the parties to discuss their differences, and on February 25, 2025, Staff filed a Status Report. Staff has since filed status reports on March 26, 2025, and on April 23, 2025. In its latest status report, Staff requested the Commission to give the parties until May 30, 2025, to file a stipulation or status report. The Commission finds the request reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a stipulation, status report, or alternative pleading no later than May 30, 2025.
2. This order shall be effective when issued.
