## ORDER DIRECTING FILING

Issue Date: March 6, 2020 Effective Date: March 6, 2020

On January 31, 2020, <sup>1</sup> Veolia Energy Kansas City, Inc. (Veolia) filed tariff sheets (Tracking No. HY-2020-0123) to revise its Production Adjustment Cost Clause (PACC) rates for steam service. The tariff sheets have a proposed effective date of April 1, 2020. The Commission directed notice of the PACC filing, directed the Commission's Staff to file a recommendation, and set a deadline for intervention. On March 5, Staff filed its recommendation to approve the tariff sheets. On March 5, the Commission issued an Order Directing Filing. Therein the Commission noted the Commission Staff had recommended approval of a tariff sheet with a different designation than any filed by Veolia and that Veolia had filed a tariff sheet with a different designation from any recommended for approval by the Staff.<sup>2</sup> The Commission ordered the parties to confer and file a recommendation or other pleadings concerning Veolia's revised tariff sheets no later than March 9.

On March 6, Vicinity Energy Kansas City, Inc. filed a Response to Order Directing Filing and a Substitute Tariff. In its response, Vicinity stated that the substitute tariff

concurrently filed remedied the discrepancy noted by the Commission. The substitute tariff is designated P.S.C. MO. No 1, 6<sup>th</sup> Revised sheet No. 37, cancelling P.S.C. MO No. 1, 5<sup>th</sup> Revised Sheet No. 37. Mindful that the Commission Staff's Recommendation to Approve Tariff Sheets recommended approval of a tariff sheet with that designation but also mindful that the said tariff sheet was filed on March 6, a day after Staff filed its recommendation, the Commission will order Staff to file its recommendation on the March 6 Substitute Tariff YH-2020-0123 in order to ensure that the parties are now "on the same page."

### THE COMMISSION ORDERS THAT:

1. No later than March 9, 2020, The Commission Staff shall file a recommendation on Veolia's revised substitute tariff YH-2020-0123:

- 2. Any party wishing to comment on the tariff sheets or respond to the Staff's recommendation shall do so no later than March 16, 2020.
