## ORDER GRANTING APPLICATION TO INTERVENE

Issue Date: April 29, 2025

On March 21, 2025,<sup>1</sup> Evergy Metro, Inc. d/b/a Evergy Missouri Metro (EMM) filed eight tariff sheets. The tariff sheets were assigned Tracking No. JE-2025-0134, and reflect proposed changes to EMM's Net Metering Option for Residential Time of Use (TOU) rates. Subsequently, the Commission set a time for applications to intervene.

On April 18, Renew Missouri Advocates d/b/a Renew Missouri timely filed an application to intervene. Renew Missouri stated that it is a non-profit policy group. Renew Missouri stated its interests are different than those of the general public. Renew Missouri further stated that granting its intervention request would serve the public interest. Renew Missouri advocated for approval of EMM's tariff sheets.

More than ten days have passed since the filing of Renew Missouri's application to intervene and no one has responded.<sup>2</sup> After considering the unopposed application to intervene, the Commission finds that Renew Missouri has interests which are different from that of the general public and also that allowing it to intervene will serve the public

interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

**THE COMMISSION ORDERS THAT:**

1. The application to intervene of Renew Missouri is granted.
2. This order shall be effective when issued.
