ORDER DELAYING STAFF RECOMMENDATION FILING

On February 28, 2020, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets in Tariff Tracking Number JG-2020-0147. The tariff sheets bear an April 1, 2020 effective date.

The Commission subsequently directed its Staff to file a recommendation no later than March 12, 2020. On March 12, 2020, Staff filed a motion requesting leave to late file Staff's recommendation on March 13, 2020, due to an anticipated filing by Liberty of a substitute WNAR tariff sheet to correct calculation errors.

Due to the request for immediate relief, and the non-harm to parties of one day delay, the Commission will not wait for responses from other parties and will approve the request, having given it due consideration.

THE COMMISSION ORDERS THAT:

1. No later than March 13, 2020, the Staff of the Commission shall file a recommendation regarding Tariff Tracking No. JG-2020-0147.

2. Any other entity wishing to respond to the tariff changes or Staff's recommendation shall do so no later than March 16, 2020.

3. This order is effective when issued.
