ORDER RECOGNIZING NAME CHANGE

Issue Date: March 20, 2020

Effective Date: April 1, 2020

Farber Telephone Company submitted a letter dated March 9, 2020, advising that it has changed its name to Farber Telephone Company d/b/a Missouriicom. The company has also filed an updated tariff to reflect the new name. That tariff carries an effective date of April 1, 2020. The Commission’s Staff filed a recommendation on March 20, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.

To allow this order to go into effect in concurrence with the tariff’s effective date, this order shall be effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Farber Telephone Company to Farber Telephone Company d/b/a Missouriicom.
2. The revised tariff filed by Farber Telephone Company d/b/a Missouriicom, (Tariff No. YI-2020-0153) will be allowed to take effect on April 1, 2020.
3. This order shall be effective on April 1, 2020.

4. This file shall be closed on April 2, 2020.


