RESPONSE TO STAFF RECOMMENDATION

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"), and for its *Response to Staff Recommendation* respectfully states as follows:

- 1. On April 24, 2025, Staff filed its *Staff Recommendation* and *Memorandum* in this matter. Staff recommended the Commission authorize Ameren Missouri to enter into a lease agreement as sought in its March 4, 2025 *Verified Application to Lease Fiber Capacity and Motion for Waiver* and grant Ameren Missouri a waiver of Commission Rule 20 CSR 4240-4.017 for good cause shown.¹ Additionally, Staff recommended the Commission include in its order a requirement that Ameren Missouri notify the Commission if it intends to terminate, suspend, or modify the lease, as well as the order note that the Commission is making no ratemaking determinations regarding the lease as part of this case.²
- 2. Ameren Missouri has reviewed the *Staff Recommendation* and *Memorandum* and does not object to the Staff's recommendations for the Commission's order as noted in paragraph 1 above.

WHEREFORE, Ameren Missouri prays that the Commission make and enter its order authorizing the lease of the fiber optic strands pursuant to the terms of the *Fiber License Agreement*
