On February 3, 2020, Spire Missouri, Inc., filed its application requesting a certificate of convenience and necessity to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Lafayette County, Missouri, as an expansion of Spire's existing certificated area.

The Commission ordered its Staff to file, no later than March 23, 2020, a recommendation or a status report indicating when it expects to file a recommendation. Staff filed a status report on March 23, 2020, and advised a number of Staff's data requests to Spire are awaiting reply or clarification. Staff requests the Commission allow Staff to file its recommendation no later than April 20, 2020.

The Commission will approve Staff's request.

### THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a recommendation regarding Spire Missouri, Inc.'s application no later than April 20, 2020.
2. This order shall be effective when issued.
