## ORDER DIRECTING STAFF TO FILE STATEMENT CONCERNING LIBERTY UTILITIES' COMPLIANCE FILING

The Commission granted Liberty Utilities, LLC a Certificate of Convenience and Necessity to install, own, acquire, construct, operate, control, manage, and maintain a sewer system at the Savers Farm Subdivision in Cape Girardeau County, Missouri. The Commission ordered Liberty Utilities to submit new and revised tariff sheets to become effective before the closing on the assets. On March 30, the company filed tariff revision YS-2020-0170 to comply with the Commission's order. The Commission will direct its Staff to file a statement informing the Commission of whether the company's tariff revision complies with the Commission's order.

### THE COMMISSION ORDERS THAT:

The Staff of the Commission shall file a statement regarding Liberty Utilities, LLC's compliance tariffs no later than April 7, 2020.
