On March 2, 2020, Evergy Missouri Metro and Evergy Missouri West (the Companies) filed a request to revise their Technical Resource Manuals (TRMs) for both companies. The Companies want to make changes to their TRMs based on incorporating additional final Evaluation, Measurement, and Verification for the Companies' program year three of their Missouri Energy Efficiency Investment Act Cycle 2. The Commission will order its staff to file a recommendation regarding the Companies' proposed TRM revisions.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file its recommendation regarding Evergy Missouri Metro and Evergy Missouri West's proposed TRM revisions no later than April 9, 2020.
