NOTICE ACKNOWLEDGING DISMISSAL

Issue Date: April 2, 2020

On July 15, 2019, the Staff of the Missouri Public Service Commission filed a *Complaint* against Rex Deffenderfer Enterprises, Inc. d/b/a RDE Water Company for failure to file its 2018 Annual Report (Count I) and failing to pay its fourth quarter fiscal year 2019 assessment (Count II). Staff filed an *Amended Complaint* on October 1, 2019, seeking to add Mr. Jim Deffenderfer, General Manager, and Ms. LaVada Deffenderfer Cottrill, President, as respondents to Count I. On April 2, 2020, Staff filed a motion to dismiss indicating that the 2018 annual report and the payment for the 2019 fiscal year assessment had been received.

Commission Rule 20 CSR 4240-2.116(1) states that a party may dismiss a complaint without an order of the Commission before prepared testimony or oral evidence

has been offered. The parties have not offered prepared testimony or oral evidence. The Commission, therefore, will take notice of the dismissal and this file shall be closed.


