NOTICE THAT FILE HAS CLOSED AND NOTICE OF NEW FILE NUMBER

Issue Date: April 7, 2020

On October 9, 2019, Union Electric Company d/b/a Ameren Missouri filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file a joint application with Three Rivers Electric Cooperative for approval of a territorial agreement. The Commission's rule provides that if the application is not filed within 180 days, the noticed case shall close.

More than 180 days have passed since Empire filed its notice and by terms of the regulation, File No. EO-2020-0101 has closed. On April 6, 2020, the 180th day after the notice was filed, Ameren Missouri filed a Request for Waiver of 60-Day Notice Expiration in EO-2020-0101 indicating its continued intention to file an application and seeking a waiver of the provision of the regulation that closes the file after 180 days.

The Commission will not waive the provision of the rule that causes the file to close after 180 days. Rather, Ameren Missouri's request will be treated as a new notice and will be assigned a new file number, EO-2020-0315. When Ameren Missouri and Three Rivers file their application they should do so in that new file.

If Ameren Missouri and Three Rivers are ready to file their application before 60 days have passed, they may request a waiver under 20 CSR 4240-4.017(1)(D) and cite the existence of the earlier notice as good cause for the waiver.
