#### MOTION FOR CLARIFICATION

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through undersigned counsel, and for its *Motion for Clarification* respectfully states as follows:

1. On May 7, 2025, the Office of the Public Counsel ("OPC") filed a *Motion for Extension* ("OPC's Motion") to file comments in this docket through May 28, 2025. OPC's Motion indicated that it had discussed the extension with Staff, Evergy Metro, Inc. d/b/a Evergy Missouri Metro, and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively, "Evergy"). Staff and Evergy indicated they had no objection to OPC's Motion. Staff subsequently did not file its comments in this matter due to OPC's Motion.

2. The Commission subsequently issued its *Order Granting Motion for Extension* ("Order") on May 9, 2025. The Order granted the OPC's extension through May 28, 2025, but the order limited the extension only to comments filed by the OPC.

3. Staff respectfully requests that the Commission clarify whether its Order applies only to OPC, or all the parties to this matter. Staff has comments regarding Evergy's Integrated Resource Plan Annual Update filings, but did not file its comments in this matter on May 7, 2025 due to the OPC's request for an extension.
