AMEREN MISSOURI QUARTERLY REPORT

COMES NOW Union Electric Company, d/b/a Ameren Missouri ("Ameren Missouri" or the "Company") and for its quarterly report on certain projects arising from the Rush Island Energy Center's ("Rush Island") retirement stated as follows:

1. According to the Commission's February 20, 2025 *Order Reducing Reporting Requirement*, the Company is to report quarterly on the items outlined below until they are complete. The Company submits this quarterly report today since the Company's last report regarding Rush Island was submitted on February 13, 2025.

Outlined below is the status of the items in question:

- Final STATCOM (in service June 2025). **Construction is nearly complete and the STATCOM is expected to be placed into service in June 2025**
- Draining oil from plant equipment (continues). **Complete**
- Plant washdowns to remove coal combustion residual material including boilers, silos, etc. (continues). **Complete**
- Continuing with the removal of all hazardous wastes (Antifreeze, feedwater chemicals, etc.). **Complete**
- Installation of temporary power to critical areas such as stack & river lighting, sump pumps, etc. (in progress). **The work is continuing and is expected to be completed by mid-June 2025**

- Asbestos survey of the plant (continues). **Complete**
- All equipment is being de-energized and Worker Protection Assurance devices installed. **The work is continuing and is expected to be completed by mid-June 2025**
- Remaining storeroom items are out for bid from vendors for removal. The transfer of pre-determined usable assets to other locations is continuing. **All storeroom items have been removed by the vendor. Transfer of assets is underway and is expected to be completed by the end of May 2025.**

WHEREFORE, Ameren Missouri hereby submits its quarterly report.
