ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: May 13, 2025

Effective Date: June 1, 2025

On April 23, 2025, the Commission issued its *Order Approving Stipulations and Agreements*, which approved two stipulation and agreements resolving this general rate case. That order rejected the tariff sheets Union Electric Company d/b/a Ameren Missouri filed to initiate this general rate case and directed Ameren Missouri to file tariff sheets in compliance with the two approved stipulation and agreements. On May 2, 2025, Ameren Missouri filed compliance tariff sheets, Tracking No. JE -2025-0150.

The Commission directed its staff to file a recommendation addressing Ameren Missouri's compliance tariff sheets by May 12, 2025. Other parties were also given until May 12, 2025, to provide comments on Ameren Missouri's compliance tariff sheets. Staff filed a recommendation on May 12, 2025, that the Commission approve Ameren Missouri's compliance tariff sheets. The Commission received no other comments about Ameren Missouri's compliance tariff sheets.

The Commission's *Order Approving Stipulations and Agreements* delegated authority to the Regulatory Law Judge to approve Ameren Missouri's compliance tariff sheets and decide if good cause exists for the tariff to take effect in less than thirty days. The *Stipulation and Agreement* filed on March 14, 2025, and approved by the Commission, provided that compliance tariff sheets are to become effective on

June 1, 2025. Therefore, good cause exists for Ameren Missouri's compliance tariff sheets to take effect in less than thirty days.

Ameren Missouri's compliance tariff sheets submitted under Tracking No. JE-2025-0150 on April 23, 2025, and tariff sheet 92.3, as substituted on May 12, 2025, will be approved to become effective with less than thirty days' notice. So that this order and Ameren Missouri's compliance tariff sheets are concurrently effective, the Regulatory Law Judge finds it reasonable to make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. The compliance tariff sheets submitted under Tracking No. JE-2025-0150 on May 2, 2025, and tariff sheet 92.3 as substituted on May 12, 2025, are approved to be effective on and after June 1, 2025.

2. This order shall become effective on June 1, 2025.
