ORDER RECOGNIZING NAME CHANGE

Issue Date: May 20, 2025

Effective Date: June 1, 2025

On May 9, 2025, the Commission received requests to recognize two name changes for Interconnected Voice over Internet Protocols (IVoIP) services as follows:

- Kingdom Telephone Company to Kingdom Telephone Company d/b/a Kingdom Networks;¹ and
- Kingdom Telecommunications, Inc. d/b/a Phynx Fiber to Kingdom Telecommunications, Inc. d/b/a Kingdom Networks.²

The Commission has reviewed the filings and 20 CSR 4240-28.011(2), and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name changes.

So that the name changes become effective on the date requested, the Commission finds it reasonable for this order to become effective in less than 30 days.
