On January 8, 2025, the Commission opened a file for the receipt of reports and responses regarding the above-referenced incident. On February 7, 2025, Summit Natural Gas of Missouri, Inc. (SNGMO) filed a response to the initial report of the Staff of the Commission (Staff). Though directed by the Commission to do so, Brightspeed of Missouri, LLC (Brightspeed) did not file a response.

The Commission will direct Staff to file a status report.

THE COMMISSION ORDERS THAT:

1. No later than June 16, 2025, Staff shall file a status report on this matter, including whether it intends to file a complaint against SNGMO and/or Brightspeed. The report shall also indicate whether Staff requests any further action by the Commission regarding a response by Brightspeed to Staff's initial incident report.
2. This order shall be effective when issued.
