NOTICE REGARDING MOTION FOR CLARIFICATION

Issue Date: May 27, 2025

On April 7, 2025,¹ the Staff of the Commission (Staff) filed a complaint alleging that City Utilities of Springfield, Missouri (CU) violated several Commission rules relating to a gas safety incident Staff investigated in File No. GS-2024-0024, including various recommendations in its filing. On April 24, CU filed a Motion to Dismiss indicating that it believed the Commission did not have jurisdiction to rule over Staff's allegations. That same day, the Commission ordered Staff to respond. On May 15, Staff filed its response stating the Commission did have jurisdiction to rule over Staff's allegations, reiterating the allegations and its recommendations.

On May 23, the Commission ordered the parties to file a procedural schedule, but did not directly address CU's *Motion to Dismiss*. On May 27, CU filed its *Reply in Support of Motion to Dismiss* and a *Motion for Clarification*.

The Commission has taken the *Motion to Dismiss* under advisement during the pendency of the case.

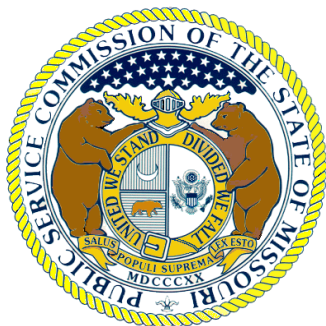
