ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On February 24, 2025, a reportable natural gas incident occurred at Spark by Hilton Branson Meadows hotel located at 263 Shepherd of the Hills Expressway in Branson, Missouri. According to Staff, multiple people were injured in this incident. At Staff's request, this case was established to receive an incident report.

On May 30, 2025, Staff filed a Status Report. Staff states that it needs additional time to complete its investigation. Staff asks the Commission to order it to file an investigatory report or a status report by August 22, 2025.

The Commission finds the request reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff shall file either its final incident report or a status report no later than August 22, 2025.

2. This order shall become when issued.

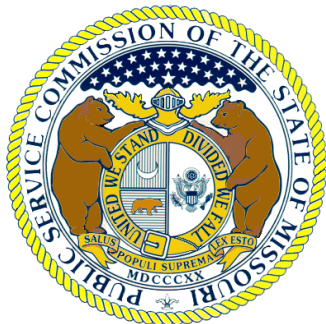
