# ORDER TO REMEDY DEFICIENCY

On April 11, 2025, Robert L. Davis, Jr., Trustee of Musiquaa Rayiys Bey PLT, filed a complaint with the Commission against Spire Missouri, Inc. d/b/a Spire. The Commission issued a notice of deficiency on April 11, 2025, because Complainant is acting on behalf of a trust, which must be represented by an attorney under Missouri law.

On April 30, 2025, Davis filed his *Request for Status on Response to Notice of Deficiency*, which the Commission treated as a request for reconsideration of its determination regarding the need for attorney representation. The Commission denied reconsideration on May 2, 2025.

On June 3, 2025, *Davis filed his Demand for Immediate Administrative Determination and Notice of Estoppel by Silence*. The Commission has already determined that a trust appearing before the Commission must be represented by an attorney.

Therefore, the Commission will direct Davis to remedy the representation deficiency by having an attorney enter on behalf of the trust or the Commission will dismiss this complaint.<sup>1</sup>

## THE COMMISSION ORDERS THAT:

1. Robert Davis shall have an attorney enter appearance on behalf of the trust by June 17, 2025, or the Commission shall dismiss this complaint.

2. This order is effective when issued.
