1. On April 7, 2025, Staff filed *Staff's Complaint* in the above-captioned cause.

2. Respondent City Utilities of Springfield, Missouri ("CU") filed a Motion to Dismiss on April 24, 2025.

3. On May 15, 2025, Staff filed its Response to CU's Motion to Dismiss.
