On May 23, 2025,¹ the Commission ordered the parties to file a proposed procedural schedule by June 6. On June 5, the Staff of the Commission (Staff) filed its *Motion for Extension of Time to File Joint Proposed Schedule* (Motion), requesting an extension of thirty days while the parties work to resolve the issues involved in this case.

The Commission finds this request reasonable and will grant the Motion.

THE COMMISSION ORDERS THAT:

1. Staff's Motion is granted.
2. No later than July 7, 2025, Staff shall file a joint proposed procedural schedule, joint status report or stipulation and agreement.

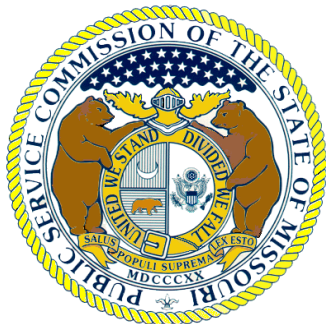
