ORDER DIRECTING FILING AND GRANTING INTERIM EXTENSION

On April 8, 2020, R.D. Sewer Co., LLC, submitted a request to extend the time allowed for filing of its 2019 annual report. Utilities subject to Commission jurisdiction are required to file reports on or before April 15 of each year. Section 393.140(6), RSMo (2016); 20 CSR 4240-10.145. Requests for extension of more than 30 days may be submitted to the Commission before April 15, as provided by 20 CSR 4240-10.145(7). Commission Rule 20 CSR 4240-10.145(7)(B) requires that a copy of the request be sent to all parties of record in pending cases before the Commission where the utility's activities are the primary focus of the proceeding.

The Commission will set a deadline for responses, if any, to R.D. Sewer's extension request. R.D. Sewer's assets are among the assets at issue in File No. WM-2020-0174 now pending before the Commission; the Commission will provide for notice of R.D. Sewer's request to the parties in that case. The Commission will excuse R.D. Sewer's obligation to file an annual report in the interim.

THE COMMISSION ORDERS THAT:

1. The Commission's data center shall provide notice of this order and R.D. Sewer Co. LLC's extension request to the parties in File No. WM-2020-0174.

2. Any objections or responses to R.D. Sewer's request shall be filed no later than April 22, 2020.

3. R.D. Sewer's obligation to file an annual report on or before April 15, 2020, is excused pending further order of the Commission.

4. This order shall be effective when issued.


MOTION FOR EXTENSION OF TIME
