## ORDER DIRECTING RESPONSES REGARDING CANCELLATION OF EVIDENTIARY HEARING REGARDING NET BOOK VALUE

On April 9, 2020, the Office of the Public Counsel, on behalf of Confluence Rivers Utility Operating Company, Inc., and Staff of the Missouri Public Service Commission, filed a Stipulation and Agreement as to Net Book Value (Net Book Value Stipulation). The Net Book Value Stipulation set forth net book values of \$20,070 for the Port Perry water system and \$57,866 for the sewer system.

On April 10, 2020, the Lake Perry Lot Owners Association filed a partial objection to the Net Book Value Stipulation, in which it objected to certain provisions of the stipulation, but agreed to the net book values.

All parties in this case now agree about the factual issue that was the subject of the evidentiary hearing scheduled for May 19-20, 2020. Therefore, the Commission sees no reason to conduct a hearing on net book value. Before cancelling the hearing, the Commission will allow parties an opportunity to respond.

### THE COMMISSION ORDERS THAT:

1. Any party wishing to object to the proposed cancellation of the evidentiary hearing scheduled for May 19-20, 2020, shall do so by April 14, 2020.
2. This order shall be effective when issued.
