**ORDER APPROVING EVERGY MISSOURI METRO AND EVERGY
MISSOURI WEST'S MODIFIED TECHNICAL RESOURCE MANUALS**

Issue Date: April 15, 2020

Effective Date: May 1, 2020

On December 20, 2019, the Commission approved modifications to Evergy's Technical Resource Manuals (TRM) to incorporate Evaluation, Measurement, and Verification (EM&V) results from program year 3 of MEEIA Cycle 2. That TRM modification was approved to become effective on January 1, 2020.

On March 2, 2020, Evergy Missouri Metro and Evergy Missouri West (collectively Evergy) filed an application for approval of modifications to their TRMs to incorporate updated EM&V results from program year 3 of MEEIA Cycle 2. Evergy requested that the modified TRM be allowed to become effective on April 1, 2020.

The Commission ordered its Staff to file a recommendation on the TRM by April 9, 2020. Other parties were given until April 14, 2020, to file any responses regarding Staff's recommendation or the modified TRM. No other party has filed a response regarding the TRM. Staff advises approval of the modified TRM effective May 1, 2020.

The proposed TRM revisions are primarily based on: (1) incorporating additional EM&V results of the Company's MEEIA Cycle 2 program year 3; (2) updating calculations

with incremental cost input updates to formulas for certain lines that were referencing incorrect cells; (3) updating hard coded values to use the applicable formulas; (4) updating measure units; and (5) updating page numbers and sources to resolve inconsistencies.

The Commission concludes that the modified TRM should be approved to be effective May 1, 2020.

THE COMMISSION ORDERS THAT:

1. The request to approve Evergy Missouri Metro and Evergy Missouri West's modified Technical Resource Manual is granted. The modified Technical Resource Manual is effective on and after May 1, 2020.
2. This order shall be effective on May 1, 2020.
