ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

On March 18, 2020, the Commission issued an order granting Liberty Utilities (Missouri Water) LLC (Liberty Water) a Certificate of Convenience and Necessity to provide sewer service in Cape Girardeau, Missouri, as an expansion of its existing certificated area. On March 30, 2020, Liberty Water filed compliance Tariff No. YS-2020-0170 pursuant to the Commission's order. The tariff has an effective date of April 29, 2020.

The Commission ordered its Staff to file a statement regarding the compliance tariffs. On April 7, 2020, Staff filed a statement recommending the Commission approve the tariff sheets filed on March 30, 2020, including the corrected map as substituted on April 6, 2020, complying with the Commission's order. After reviewing the substitute tariff sheets and Staff's statement concerning the compliance tariffs, the Commission finds that Liberty Water's tariff sheets comply with the Commission's order granting a Certificate of Convenience and Necessity, and will approve them.

THE COMMISSION ORDERS THAT:

1. Liberty Utilities (Missouri Water) LLC's Tariff No. YS-2020-0170, with the map as substituted on April 6, 2020, is approved to become effective on April 29, 2020.
