ORDER APPROVING TARIFFS IN COMPLIANCE WITH COMMISSION ORDER

On July 16, 2001, Missouri Gas Energy (MGE), a division of Southern Union Company, submitted tariff sheets pursuant to an Order Approving Second Revised Stipulation and Agreement issued by the Commission on July 5, 2001. MGE's tariff carries an effective date of August 15, 2001. However, along with its tariff, MGE filed a Motion for Expedited Consideration asking that the Commission approve the tariff to be effective on less than thirty days' notice. MGE asks that the tariff be made effective on August 6, 2001, consistent with the Second Revised Stipulation and Agreement. At the request of the Staff of the Commission, MGE filed substitute tariff sheets on July 31, 2001, to correct certain typographical errors and an administrative oversight.

On August 2, 2001, the Staff filed a recommendation and memorandum indicating that it has reviewed the tariff sheets and finds that they comply with the Commission's order. Staff recommends that the tariffs be approved to be effective August 6, 2001.

The Commission has reviewed the tariff filing and the Staff memorandum, and has determined that the filing is in compliance with the Commission's order.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets (Tariff File No. 200200040) filed July 16, 2001, as substituted on July 31, 2001, are hereby approved to become effective on August 6, 2001.
