On May 1, 2020, American Broadband and Telecommunications Company d/b/a American Assistance (American Assistance) filed a letter informing the Commission that it wishes to relinquish its designation as an eligible telecommunications carrier in Missouri effective July 2, 2020. The Commission will give notice of American Assistance's filing and will direct its Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to all wireless eligible telecommunications carriers serving Missouri.
2. Any proper person wishing to intervene in this matter shall file an application to do so no later than May 21, 2020.
3. Staff shall file its recommendation regarding American Assistance's notice no later than June 1, 2020.
4. Any other party wishing to respond to American Assistance's notice shall do so no later than June 1, 2020.
5. This order shall be effective when issue.
