The Commission has undertaken this rulemaking to modify the Commission's rules regarding filing requirements for electric utility cogeneration and net metering. The Commission finds that the rule amendments are appropriate and necessary to protect the public interest and to carry out the purposes of the statute that granted the Commission authority to regulate in this area.

These rule amendments were developed with input from interested stakeholders through Commission file numbers EW-2017-0245 and EW-2018-0078, and the Commission will seek further comments from interested stakeholders during the rulemaking process.

#### THE COMMISSION ORDERS THAT:

The Secretary of the Commission shall file the rule amendments (20 CSR
4240-20.060 – Cogeneration and Small Power Production; 20 CSR 4240-20-065 – Net

Metering; and the proposed rescission of 20 CSR 4240-3.155 – Requirements for Electric Utility Cogeneration Tariff Filings) with the Secretary of State as proposed rule amendments and rescission.
